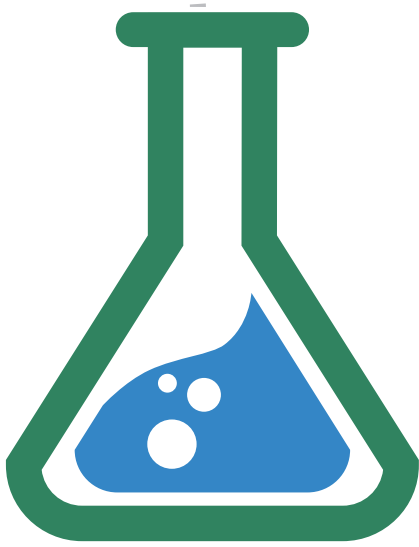

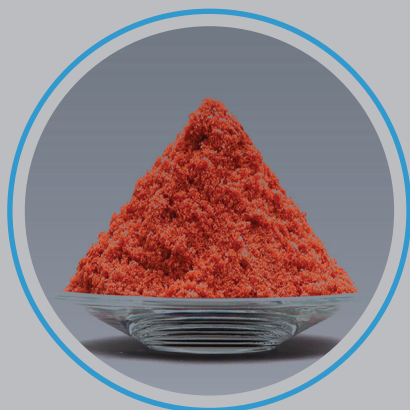

# What We Do

## Chemical Solutions

### A) Hydro-metallurgical Reagents



#### i) Cobalt Sulphate ( Industrial application)

Cobalt sulphate is used in the Copper Industry, mostly in electro winning processes to improve cathode quality. We source this material directly from renowned refineries around the world most notably from India and China. All we need is the specification per user requirement and we deliver it to you at affordable rates without compromising on Safety and product quality.

#### ii) Flocculants

We provide both the Pre and Post leach flocculants as maybe required. Our Flocculants comes with a technical support whenever, required.

Packaging can be as per user requirement but mostly it comes in 25Kgs.



#### iii) Guar Gum Powder

We supply Guar Gum used in electro winning process for production of base metals e.g. copper cathode as a smoothing agent to improve the quality and it is widely used in food industry as well.



#### iv) Mining solvent ( Shelsol 2325, Ash H & Fluiden)

Solvent extraction is widely employed in a variety of industries for both the upgrading and purification of a range of base metals.

## B) Beneficiation Reagents

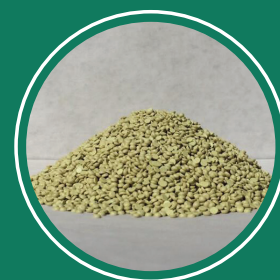


### C) Pyro-metallurgical Requirements

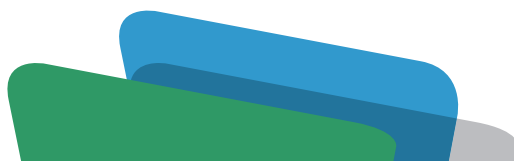
